MISHAP REPORTING AND INVESTIGATION

CAPR 62-2, 27 November 2007 w/Change 1, is supplemented as follows:

3. a. (Added). Pacific Region Mishap Notification-Accident and Incidents. All mishaps meeting the criteria of an accident or incident, as defined in CAPR 62-2 w/change 1, dated 27 November 2007, 1.b. and 1.c., shall be telephonically reported to Headquarters, Pacific Region immediately (**within two hours of a Wing Commander or Wing Safety Officer being notified of a Mishap**) in addition to the notification(s) required in CAPR 62-2, 4. Wing Commanders will ensure that the Wing Safety Officer or his/her designee shall telephone the following individuals in the order listed until one person is reached. That person will notify the remainder of the list by appropriate means. (**Preferred phone number in bold**).
