MISHAP REPORTING AND INVESTIGATION

CAPR 62-2, 20 May 2014 is supplemented as follows:

SUMMARY OF CHANGES.

This change incorporates the new Region Safety Officer and PLR/ADOs. Reporting to PLR is now required. Note: Shaded areas identify new or revised material.

3a. (Added) Pacific Region Mishap Notification. All mishaps shall be telephonically reported to Headquarters, Pacific Region immediately (within two hours of a Wing Commander or Wing Designee being notified of a Mishap) in addition to the notification(s) required in CAPR 62-2. paragraph 3. Wing Commanders will ensure that the Wing Safety Officer or his/her designee shall telephone the following individuals in the order listed until one person is reached. That person will notify the remainder of the list by appropriate means. ONLY the Wing Commander has the discretion to override the need for telephonic notification (Preferred phone number in bold).

3b. (Added) Pacific Region Mishap Notification-Minor Mishaps. All mishaps meeting the criteria of First Aid Only/Matter of Record as defined in CAPR 62-2, shall be reported to Headquarters, Pacific Region immediately using the procedure stated in 3a above, or via other appropriate electronic means, including email. If email is used, all email addresses below shall be included:
